The five-year projection for the population in the area is 331,784 representing a change of 0.67% annually from 2024 to 2029. Currently, the population is 49.8% male and 50.2% female.

Currently, 41.1% of the 163,287 housing units in the area are owner occupied; 50.6%, renter occupied; and 8.3% are vacant. Currently, in the U.S., 57.9% of the housing units in the area are owner occupied; 32.1% are renter occupied; and 10.0% are vacant. In 2020, there were 153,980 housing units in the area and 8.4% vacant housing units. The annual rate of change in housing units since 2020 is 1.39%. Median home value in the area is \$538,069, compared to a median home value of \$355,577 for the U.S. In five years, median value is projected to change by 2.51% annually to \$609,044.
