Currently, 39.9% of the 140,851 housing units in the area are owner occupied; 51.5%, renter occupied; and 8.6% are vacant. Currently, in the U.S., 56.4% of the housing units in the area are owner occupied; 32.3% are renter occupied; and 11.3% are vacant. In 2010, there were 124,780 housing units in the area - 42.6% owner occupied, 47.3% renter occupied, and 10.0% vacant. The annual rate of change in housing units since 2010 is 5.53%. Median home value in the area is \$408,710, compared to a median home value of \$235,127 for the U.S. In five years, median value is projected to change by 1.28% annually to \$435,615.
