Currently, 75.3% of the 74,849 housing units in the area are owner occupied; 20.5%, renter occupied; and 4.2% are vacant. Currently, in the U.S., 56.4% of the housing units in the area are owner occupied; 32.3% are renter occupied; and 11.3% are vacant. In 2010, there were 66,098 housing units in the area - 76.0% owner occupied, 18.4% renter occupied, and 5.6% vacant. The annual rate of change in housing units since 2010 is 5.68%. Median home value in the area is \$277,204, compared to a median home value of \$235,127 for the U.S. In five years, median value is projected to change by 1.48% annually to \$298,278.
