Currently, 64.8% of the 37,932 housing units in the area are owner occupied; 29.7%, renter occupied; and 5.5% are vacant. Currently, in the U.S., 58.5% of the housing units in the area are owner occupied; 31.7% are renter occupied; and 9.8% are vacant. In 2020, there were 35,834 housing units in the area and 5.9% vacant housing units. The annual rate of change in housing units since 2020 is 1.77%. Median home value in the area is \$218,055, compared to a median home value of \$308,943 for the U.S. In five years, median value is projected to change by 1.00% annually to \$229,186.
