Currently, 45.0% of the 123,345 housing units in the area are owner occupied; 47.8%, renter occupied; and 7.1% are vacant. Currently, in the U.S., 58.5% of the housing units in the area are owner occupied; 31.7% are renter occupied; and 9.8% are vacant. In 2020, there were 121,230 housing units in the area and 7.1% vacant housing units. The annual rate of change in housing units since 2020 is 0.53%. Median home value in the area is \$345,375, compared to a median home value of \$308,943 for the U.S. In five years, median value is projected to change by 1.18% annually to \$366,231.
