Currently, 44.5% of the 70,699 housing units in the area are owner occupied; 42.5%, renter occupied; and 13.0% are vacant. Currently, in the U.S., 58.5% of the housing units in the area are owner occupied; 31.7% are renter occupied; and 9.8% are vacant. In 2020, there were 69,870 housing units in the area and 12.8% vacant housing units. The annual rate of change in housing units since 2020 is 0.36%. Median home value in the area is \$282,281, compared to a median home value of \$308,943 for the U.S. In five years, median value is projected to change by 2.28% annually to \$315,954.
