In the identified area, the current year population is 191,467. In 2020, the Census count in the area was 189,646. The rate of change since 2020 was 0.29% annually. The five-year projection for the population in the area is 190,454 representing a change of -0.11% annually from 2023 to 2028. Currently, the population is 49.0% male and 51.0% female.

Currently, 63.6% of the 80,006 housing units in the area are owner occupied; 31.8%, renter occupied; and 4.6% are vacant. Currently, in the U.S., 58.5% of the housing units in the area are owner occupied; 31.7% are renter occupied; and 9.8% are vacant. In 2020, there were 79,101 housing units in the area and 4.8% vacant housing units. The annual rate of change in housing units since 2020 is 0.35%. Median home value in the area is \$471,243, compared to a median home value of \$308,943 for the U.S. In five years, median value is projected to change by 1.28% annually to \$502,171.
