Current median household income is \$96,942 in the area, compared to \$79,068 for all U.S. households. Median household income is projected to be \$108,492 in five years, compared to \$91,442 all U.S. households.

Current average household income is \$120,965 in this area, compared to \$113,185 for all U.S. households. Average household income is projected to be \$139,124 in five years, compared to \$130,581 for all U.S. households.

Current per capita income is \$44,853 in the area, compared to the U.S. per capita income of \$43,829. The per capita income is projected to be \$52,046 in five years, compared to \$51,203 for all U.S. households.

Currently, 66.3% of the 67,947 housing units in the area are owner occupied; 29.4%, renter occupied; and 4.3% are vacant. Currently, in the U.S., 57.9% of the housing units in the area are owner occupied; 32.1% are renter occupied; and 10.0% are vacant. In 2020, there were 64,474 housing units in the area and 4.7% vacant housing units. The annual rate of change in housing units since 2020 is 1.24%. Median home value in the area is \$375,482, compared to a median home value of \$355,577 for the U.S. In five years, median value is projected to change by 2.44% annually to \$423,499.
