Current median household income is \$82,780 in the area, compared to \$79,068 for all U.S. households. Median household income is projected to be \$102,446 in five years, compared to \$91,442 all U.S. households.

Current average household income is \$127,085 in this area, compared to \$113,185 for all U.S. households. Average household income is projected to be \$149,509 in five years, compared to \$130,581 for all U.S. households.

Current per capita income is \$60,469 in the area, compared to the U.S. per capita income of \$43,829. The per capita income is projected to be \$73,293 in five years, compared to \$51,203 for all U.S. households.

Currently, 35.3% of the 190,206 housing units in the area are owner occupied; 52.2%, renter occupied; and 12.4% are vacant. Currently, in the U.S., 57.9% of the housing units in the area are owner occupied; 32.1% are renter occupied; and 10.0% are vacant. In 2020, there were 173,803 housing units in the area and 12.2% vacant housing units. The annual rate of change in housing units since 2020 is 2.14%. Median home value in the area is \$485,181, compared to a median home value of \$355,577 for the U.S. In five years, median value is projected to change by 4.45% annually to \$603,188.
