In the identified area, the current year population is **204,156**. In 2020, the Census count in the area was **187,742**. The rate of change since 2020 was **1.35%** annually. The five-year projection for the population in the area is **214,672** representing a change of **1.01%** annually from 2026 to 2031. Currently, the population is **49.1%** male and **50.9%** female.

Households by Income

Current per capita income is **\$54,004** in the area, compared to the U.S. per capita income of **\$48,241**. The per capita income is projected to be **\$61,315** in five years, compared to **\$55,073** for all U.S. households.

Currently, **74.2%** of the **79,310** housing units in the area are owner occupied; **22.8%** renter occupied; and **3.1%** are vacant. Currently, in the U.S., **57.6%** of the housing units are owner occupied; **32.4%** are renter occupied; and **10.0%** are vacant. In 2020, there were **72,077** housing units in the area and **78** vacant housing units. The annual rate of change in housing units since 2020 is **1.54%**. Median home value in the area is **\$440,405**, compared to a median home value of **\$376,272** for the U.S. In five years, median home value is projected to change by **2.67%** annually to **\$426,203**.
